<b>Target Market</b>	<p><b>Description of target market</b></p> <p>Consumers that are looking to purchase land to build, to refinance from another financial institution, to purchase or build a home with the flexibility to make additional repayments and redraw funds as required.</p> <p><b>Description of product, including key attributes</b></p> <p>The First Rate home loan is our standard variable interest rate loan that gives flexible repayment options, no monthly account keeping fees and more.</p> <p>The product's key attributes are:</p> <ul style="list-style-type: none"> <li>• Principal and interest payments</li> <li>• Unlimited free redraw</li> <li>• Loan period available up to 30 years</li> <li>• No monthly account keeping/service fees</li> <li>• Top up facility available</li> <li>• No penalty for early pay outs</li> <li>• Ability to make additional repayments at no extra cost</li> <li>• Option to split the loan between fixed and variable</li> <li>• Ability to use family guarantee</li> </ul>

**Description of likely objectives, financial situation and needs of consumers in the target market**

The product has been designed for consumers that:

- Are seeking the flexibility to make extra repayments without a fee and/or seeking flexibility to redraw funds as required
- Meet Unity Bank's credit assessment requirements and receive sufficient regular income
- Are seeking the ability to drawdown the loan progressively for loans for construction purpose
- Can provide residential property to secure the loan
- Need funds to purchase land to build, to refinance from another financial institution, to purchase or build a home.

**Classes of consumers for whom the product is clearly unsuitable**

- Consumers that do not meet the eligibility criteria
- Consumers that are determined unsuitable by the lender due to high credit risk
- Consumers that require interest only payments over the first 1- 5 years
- Consumers that want a loan term greater than 30 years
- Consumers that want to link an offset facility to their home loan
- Consumers that want to fix their interest rate at the commencement of their loan
- Consumers that want a line of credit facility
- Consumers that have defined goals and objectives and are not met by this product

**Distribution channels**

The product is designed to be distributed through the following means:

- Direct distribution by Unity Bank employees via branch, online and phone
- Unity Bank accredited mortgage brokers

**Distribution conditions and restrictions**

The distribution of the product is subject to the following conditions and restrictions:

- Consumer meets the minimum age of 18
- Consumer is an Australian citizen or permanent resident
- Consumer meets the credit eligibility criteria
- Be a shareholder or become a shareholder of Unity Bank
- Unity Bank to ensure staff are accredited and authorised as product distributors
- Unity Bank to ensure Third Party distributors are industry qualified and fully accredited
- Consumers with appropriate borrowing capacity

In addition, Unity Bank completes further upfront evaluations, ongoing due diligence and monitoring of product training to our staff.</p>
<p><b>Reviews Triggers</b></p>	<p>We will undertake a review of this TMD in the following circumstances:</p> <p><b>Complaints</b></p> <ul style="list-style-type: none"> <li>• Consumer complaints (in number or significance) within a 3 month period regarding understanding of risks, key terms, conditions or features of this product.</li> </ul> <p><b>Feedback from Third Party distributors</b></p> <ul style="list-style-type: none"> <li>• Reporting received, or consistent feedback from Third Party distributors which suggests that the target market may no longer be appropriate.</li> </ul> <p><b>Substantial product change</b></p> <ul style="list-style-type: none"> <li>• When a substantial change is made to the product terms, conditions or key attributes</li> <li>• If we make a material change to the design or distribution of the product</li> </ul> <p><b>Product performance</b></p> <ul style="list-style-type: none"> <li>• Evidence that consumer usage is significantly different from original expectations and contrary to the design of the product</li> <li>• Evidence that product is no longer meeting the financial situation, needs and objectives of the target market</li> <li>• Evidence of substantial sales outside of the target market</li> <li>• If the product's design or distribution receive adverse media coverage</li> </ul> <p><b>Significant change to the external environment</b></p> <ul style="list-style-type: none"> <li>• Regulatory or legislative environment for this product</li> <li>• Economic and market conditions</li> </ul> <p><b>Notification from ASIC and/or AFCA</b></p> <ul style="list-style-type: none"> <li>• ASIC request immediate cessation of product distribution, or cessation of particular conduct in relation to the product</li> <li>• If ASIC raises concerns about the product's design or distribution</li> <li>• If the Australia Financial Complaints Authority or a Court raise concerns about the product's design or distribution</li> </ul> <p><b>Significant dealings</b></p> <ul style="list-style-type: none"> <li>• A significant dealing of the product to consumers outside the target market occurs</li> <li>• If any other event or circumstance occurs indicating that this TMD may no longer be appropriate.</li> </ul> <p>Where a review trigger or event occurs, we will review this TMD within 10 business days.</p>

<p><b>Review Periods</b></p>	<p><b>Initial review</b></p> <p>We will undertake a review of this TMD within 12 months of the effective date.</p> <p><b>Periodic review</b></p> <p>We will undertake periodic reviews of this TMD at least every 2 years from the initial review.</p>
<p><b>Distributors Reporting Requirements</b></p>	<p><b>Complaints</b></p> <p>Distributors must report to us in writing within 10 business days they become aware of a complaint related to risks, key terms, conditions or features of this product including:</p> <ul style="list-style-type: none"> <li>• The number of complaints</li> <li>• The nature and circumstances of the complaint; and</li> <li>• The substances of those complaints and any general feedback relating to the product or its performance.</li> </ul> <p><b>Significant dealings</b></p> <p>Distributors must report to us in writing within 10 business days they become aware of a significant dealing in the product that is inconsistent with this TMD. This also applies when we distribute our own product. Written notification needs to include the following:</p> <ul style="list-style-type: none"> <li>• Date(s) the significant dealing occurred;</li> <li>• Description of the significant dealing and why it is not consistent with the TMD;</li> <li>• Why the dealing is significant;</li> <li>• How the significant dealing was identified; and</li> <li>• What steps, if any, have been, or will be, taken in relation to the significant dealing.</li> </ul>
